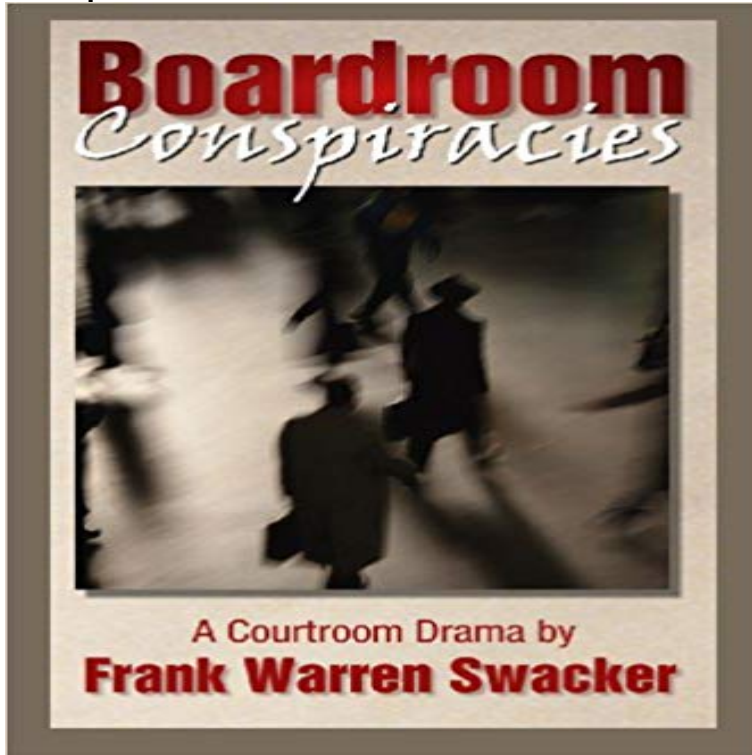


## Boardroom Conspiracies and Who Murdered the Chairman? A Comic Corporate Satire in Two Acts

ABOUT THE AUTHOR Frank Warren Swacker was born May 18, 1922 in Manhattan. The author is a second generation Wall Street lawyer. He received his B.A. (Economics) degree from Union College, a Juris Doctor from The University of Virginia School of Law and a LL.M. (International Law) from New York University Graduate School of Law. The author served for a decade as the International Counsel of a multibillion dollar conglomerate and as a director of both private and public corporations. He has acted as an advisor to major corporations, law firms and governments on trade and investment matters both here and abroad. As a former member of the

Stetson University, College of Law faculty, he taught international commercial arbitration. He has appeared on television round tables and has lectured extensively on the W.T.O. and on doing business in various parts of the world. He is listed in WHOS WHO IN THE WORLD, WHOS WHO IN AMERICA and WHOS WHO IN AMERICAN LAW. The author and his wife, Irene Michael Swacker, live in St. Petersburg, Florida. This is the author's seventh book and his first foray into fictional satire. Among his previous publications is the popular: INTERNATIONAL BUSINESS ADVISOR FOR GOING GLOBAL (1999). He has since published WHO MURDERED MOM? (2006), and written full length two act plays. The play entitled, WHO MURDERED THE CHAIRMAN? based upon this book, only requires a cast of 8 characters.
